#### **IDENTIFICATION REQUIREMENTS**

We must verify the identity and address of all parties connected to an account. All documents provided must be an **original** or a **certified copy** of the original document and must be clear and legible. The entire document must be provided. For documents that are not in English, a certified English translation must be provided which confirms the translation is accurate.

- 1. I/We hereby irrevocably and unconditionally apply to invest the sum stated in section 2 of this Application Form in Shares of the Fund pursuant to the Fund's Memorandum and Articles of Association and to the Scheme Particulars;
